Dear Consumers,

PharmPix is committed to the health and well-being of patients. For this reason, we are notifying you that on February 16, 2021, the U.S. Food and Drug Administration (FDA) published a voluntary recall for all lots of Adam's Secret Extra Strength 1500 and Adam's Secret Extra Strength 3000 capsules, manufactured by Adamssecret.co.

This recall has been initiated after an FDA laboratory analysis found the product to contain undeclared sildenafil and/or tadalafil. Sildenafil and tadalafil are ingredients in FDA approved products for the treatment of male erectile dysfunction in the family of drugs known as phosphodiesterase (PDE-5) inhibitors. The presence of sildenafil and/or tadalafil in Adam's Secret Extra Strength products makes them unapproved new drugs for which the safety and efficacy have not been established and therefore subject to recall. Consumers with underlying medical issues who take Adam's Secret Extra Strength 1500 or Adam's Secret Extra Strength 3000 capsules with undeclared sildenafil and tadalafil may experience serious health risks. For example, PDE-5 inhibitors may interact with nitrates found in some prescription drugs (such as nitroglycerin), lowering blood pressure to dangerous levels that may be life-threatening. Consumers with diabetes, high blood pressure, or heart disease often take nitrates.

The product is marketed as a dietary supplement for male sexual enhancement and is packaged in blister foil sheets and a box containing 10 capsules. Adam's Secret Extra Strength 1500 and 3000 were distributed via [the internet](http://theinternet.com) at www.adamssecret.com nationwide in the USA.

Consumers required actions(s):

- Identify if the product is in inventory and immediately stop using and return to the place of purchase.
- Contact their physician or healthcare provider if they have experienced any problems that may be related to taking or using these drug products.
